#### Accommodation

Accommodation with a carefully selected homestay includes breakfast and an evening meal 7 days a week and a snack lunch, if required, at the weekend. Cost (when not already included in the course fee) £167 per week. Additional nights £35 per night (subject to availability).

Residential accommodation is available for adults 18+ in the summer cost £269 per week.
